# Campbell Wins Will Rogers Award

Bill Campbell, an AFPAAA Lifetime Member, has been honored with the National

Society of Newspaper Columnists' Will Rogers Humanitarian Award. The award, a statuette of the farsighted philosopher-humorist of the 1920s and '30s, who used his forum as a commentator for humanitarian purposes, was presented in June by Rogers great-grandson, James, at the society's conference in New Orleans.

Bill, who now writes for the Beachcomber in Destin, Florida, has been a columnist for the past 20 years. Community service has been the theme for many of his writings as he supported a wide variety of non-profit organizations and involved himself personally with a number of these groups. As president of the local unit of the American Cancer Society, Bill was instrumental in the launching of "Relay for Life," a program that has raised more than \$1 million to benefit cancer patients.

A physician who praised his efforts to urge men to get checked for prostate cancer at an annual free screening nominated him for the award.

This was the ninth time the Will Rogers Humanitarian Award has been presented and for the first time the judging ended in a tie that resulted in two winners.

In addition to Bill, Carol A. Dawson, who writes "The Extra Miler' column for the Indiana's Jeffersonville Evening News and The New Albany Tribune, received the award.
