# By-laws Change Welcomes Bandsmen To Association


Several of the Association's Board of Directors looked at the new Air Force Public Affairs coin and agreed 'we should include the Bandsmen in our membership.'

# Edwin L. Dougherty

Edwin Dougherty, who directed the U. S. Air Force Drum and Bugle Corps in the early 1950s and retired as a Captain in 1961, died of cancer at his home in Accokeek, Maryland, May 25.

Dougherty was from Port Byron, New York. He studied at the Ernest William School of Music in Brooklyn and graduated from Mansfield University in Pennsylvania. His instrument was the tuba.

He entered military service as an infantryman in 1941. By 1944 he was a member of the Army Air Corps Band.

He led the Drum and Bugle Corps in performances in Europe, Asia, and the United States. He was at Andrews AFB in the late 1950s and directed a number of other bands prior to his retirement.

Dougherty was a music teacher at Accokeek's Eugene Burroughs Junior High School for 15 years and he was a part-time instructor at several other schools in Prince George's County, Maryland, for the next five years. He lived in Melbourne, Florida, from 1984 until this year.

He is survived by a brother and a sister, five children, and nine grandchildren.

# Minutes – Third Annual Membership Meeting Air Force Public Affairs Alumni Association

**General** – The Third Annual Membership Meeting of the Air Force Public Affairs Alumni Association was called to order at 9 AM on Saturday, July 13, 1996, at the Radisson Hotel, Hampton, Virginia, by the Association's President and Chairman of the Board of Directors, Mike McRaney.

**Quorum** – Secretary John Terino reported that the more than 70 full members attending the meeting met the quorum requirement and the meeting could proceed.

**Remembrance of Deceased** – Mike McRaney asked all present to remember those of the Public Affairs, Broadcasting, and Band communities who had passed away during the preceding year, including Tom Coleman, Mike DeStephanis, Lee Hogan, George Howard, Helen McCarthy, Jack Newman, George Schenkein, Pete Sloan, and Bob Zehring. Ben Scarpero suggested that we allow a few minutes for members who wished to say a few words about friends no longer with us to stand up and address the group. Mike said the Board would take his suggestion under consideration.

**Finances** – Treasurer Pete Alexandrakos presented the financial report from May 31, 1995 through June 31, 1996 (Annual Meeting to Annual Meeting), exclusive of the 1996 Annual Membership Meeting. The period began with \$30,310.66 and ended with a \$33,536.97 balance of funds. Membership dues receipts for this year were \$9,090, down from the \$25,000 collected in the 1994-95 year. Investment income increased to \$1,470 as did donations to the Oral History program, which totaled \$1,950.

He pointed out that our expenses would have been many thousands of dollars higher if Jim Hart and PanEnergy had not picked up the cost for our printing and mailings during the year. In addition, many more thousands of dollars were saved by the donation of services by Board members, officers, committee chairs, and volunteers.

The budget year runs from October 1 through September 30 to coincide with our accounting year for tax purposes. Pete reported the budget is on target. Income is a little ahead of forecast and expenditures are where they should be; if that continues we will end the year with a surplus.

We are in good financial shape right now, and things look pretty good for the immediate future. Next year a big income source will be renewal of three-year memberships - there are 177 who joined in 1994. We also have good income potential from more than 100 oneyear members up for renewal. The last two years, one-year members have renewed at about an 82%-85% rate. Assuming an 80% renewal rate for the three- and one-year members in 1997, we will have income of about \$8,000. Moderately successful recruiting and upgrades from one-year to three-year memberships and to Lifetime Memberships would provide additional income.

Our investments are in CDs with rates ranging from 5.25% to 5.8%. We will continue to seek the best rates available. We are pleased with the donations to the Oral History Program and as more histories become available we look for donations to increase.



Jim Hart's work as Development Committee Chairman has resulted in donations from a number of companies, including those of Association members. For this meeting, donations total \$2,100.

We have enough reserves to get us through one year when the donated services we have now are no longer available. The long term challenge is to have a revenue base that can support our programs on a continuing annual basis. We are working on that.

**Membership** – Membership Chairman Neil Buttimer said the major tasks were keeping the data base current, getting membership certificates out, and the directory. Current membership is 575.

Neil stressed that, in addition to retirees, we need to get more people from the active Air Force, and that the Association's members are its recruiters. The soon-to-be published *Tips for Transition* booklet should help in communicating the usefulness of the Association to potential members. The just passed amendment to the by-laws that adds Bandsmen to the Association should produce more members. Our membership drive produced three winners of Oral Histories -Chuck Lucas, Jack Rose, and Roy Whitton.

Neil encouraged prompt membership renewal to save the costs of multiple mailings and the time involved in following-up. Also, members need to keep their directory listings current. Neil asked for volunteers to form a 'marketing team' that would produce and execute ideas for recruiting new members.

**Election** – John Ohlsen and Sam Lessey counted the Board of Directors Election ballots. Mike McRaney reported that Pete Alexandrakos, Alice Price, John Terino, and he were reelected to the Board. John Gura was newly elected, replacing Chuck Davis.

**Oral History Program** – John Gura said 33 interviews were done, 17 have been published, and the rest are in various stages of production. Cost of transcription (30-60 pages each) averages about \$180. Production costs of the 20 copies that are done to meet distribution requirements is between \$90 and \$250. The Oral Histories are being sent to the Air Force Academy Library, DINFOS, the Air Force History Program, Air Force Association's Aerospace Education Foundation, SAF/PA, PRSA Research Library, the University of Florida at Gainsville, the University of Texas at Austin, Boston University, Purdue, and San Diego State University. Based on talks with Ron Sconyers and Ron Rand, we expect a request for copies for the major commands. John asked for suggestions for people to be interviewed. As a tax-exempt veterans organization, donations can be made in any amount specifically to the Oral History Program or to the Association in general.

Katie Cutler pointed out that all those interviewed to-date were male and asked if we intended to interview any women so there would be some role models in the collection. John Gura said that we had just completed Alice Price and that we would do others the opportunities presented themselves.

Roy Whitton suggest that we interview a prominent past band

commander as quickly as possible to show our commitment and to aid recruiting. John Gulick suggested we put the availability of the histories on the World Wide Web via the SAF/PA site. John Terino said there may be a potential problem in doing that because it would show favoritism to our organization. The issue will be explored with SAF/PA.

**Award Program** – Mike McRaney said the Association had responded to an emergency request for funds to get the PA Coin project started. The 'Best of the Best' program is going real well.

**SAF/PA Coordination** – Mike McRaney reported that it is going very well at all levels and that a lot of the kinks had been ironed out during the past year as was testified to by General Sconyers in his luncheon remarks yesterday.

**Membership Survey**–Mike McRaney reported that the membership survey discussed at last year's meeting had been completed thanks to the assistance of Jim Hart and PanEnergy Corp. The results have been used by the board to guide it in its work.

**Tips for Transition Booklet** – Responding to the survey, Board member Kathy McCollom had put together a 'Tips for Transition' booklet that will be published shortly for members use. It will also be sold. The booklet contains the experiences of many of the members and their contributions are appreciated.

**Civilian Award** – Jack Rose proposed that the Association establish a Gladys Wise Memorial Award for the outstanding civilian in Public Affairs that would not conflict with the 'Best of the Best,' saying it could be on a secondary level and he would help fund it. Several members voiced agreement. Jerry Dalton said we should check with SAF/PA before we do anything. John Terino said there were a lot of prominent civilians who the award could be named after but SAF/PA would have to O.K. it and do the selection. Mike McRaney said the Board would consider the proposal and report back to the membership.

**Best of the Best Recipient at Annual Membership Meeting** – Gil Whiteman suggested the winner be invited to the annual meeting at Association expense. Mike McRaney said that issue had been under discussion and the Board was still wrestling with it.

**Web Site** – Don Brownlee said his investigation of a page for the Association was inconclusive and the benefits to be derived questionable. He will continue to explore it.

**Regional Activities** – Mike McRaney said chapters and regions had been discussed extensively by the Board and it concluded that chapters wouldn't work but regional activities probably would work, if there were volunteers to take on the task. The Association would provide lists of names and addresses, labels, and perhaps a little money now and then. Regions could be Los Angeles, San Antonio, Colorado Springs, etc., but someone has to step up and do the work in each area because the Board has a full plate. Gil Billings asked what the regions would do. Mike said that was up to the people in the region; to date, the interest was high but the number of volunteers was not commensurate with the interest. Ralph Evans said this could be a means to help the active force in an area. Mike asked for those who wanted to take on the task to let the Board know. **Appreciation** – Mike expressed his appreciation to the corporate sponsors and those who donated gifts. He asked if we should continue those efforts and the sense of those present was we should. He thanked Rob Elsass, Jim Caldwell, Donna Christian, John Peters and Ron Rand and his staff for their support in organizing and running the meeting. Mike asked for feedback from the members to make it better next year.

Annual Meeting – Mike McRaney announced that the Association's 1997 Annual Membership Meeting would be in Las Vegas in conjunction with the Air Force/Air Force Association celebration of the 50th Anniversary of the Air Force, April 22-26. Dave Shea said we will have a display booth in the Convention Center; a business meeting in conjunction with a brunch, lunch, or dinner; we will have rooms in a hotel; members will be encouraged to take part in the celebration events; and early registration is important to avoid increased prices – details will be provided as our plans are completed. More than three-quarters of the members present indicated they were planning to attend the celebration

**Adjournment** – With no other business to conduct the meeting was adjourned and the drawing for gifts began.

# Technology Has Pushed Service Past The 'Wild Blue Yonder' . . .

Recently, Air Force Chief of Staff General Ronald R. Fogelman has said several times "As we approach the dawn of the 21st century, I am convinced it will be the century of aerospace power..."

Because this recognition of the tremendous advances in technology is exactly on target, it seems only natural that the United States Air Force should seriously consider changing its name to the United States Aerospace Force.

### 1907 U. S. Signal Corps Aeronautical Division

For much of the past decade, Air Force leaders have shied away from terminology they had used for many years. Late in 1990, key spokesmen began substituting 'air and space' for 'aerospace' in their public statements.

But recently, Air Force scientists and technologists, looking ahead to the 21st century in their December 1995 *New World Vistas* study, noted that "the domain

of conflict is moving from Earth into space and even into cyberspace," and that "the future force will, eventually, contain space, ground, and airborne weapons that can project photon energy, kinetic energy, and information against space and ground assets."

Air and space is an inherently divisive term, which, at least subliminally, implies a significant operational disjunction between the atmosphere and the regions beyond.

Isn't today's Air Force more than a military force that operates only in the air – as its name implies? Of what does the air consist and what are its boundaries? Does air

mean only the atmosphere,as in its

original

dictionary definition?

Could the United States Air Force more accurately be called the United States Atmospheric Force?

refer in their public speeches to "dominance of the skies."

How high is the sky? How far beyond the Earth's surface can objects be seen by the naked eye? Some objects, of course, can be seen far beyond the atmosphere – in space. So, when we look into the sky, what we see is aerospace – not merely air.

These questions about what is included in the world "air," and how one should define "sky" seem elemental, but they are significant in light of the dichotomy of language in the official Air Force lexicon.

In an article in the August 1958 Air Force Magazine,

Air Force Chief of Staff General Thomas D. White mentioned aerospace publicly for the first time. The Air Force began using the word widely in 1958 and adopted Aerospace Power for Peace as its slogan in 1959. The term was adopted in Air Force doctrine manuals and used regularly for three decades to define the total expanse beyond the Earth's surface as an undivided operational realm.

Aerospace has been embraced as an apt and useful term by industry, science, and education.

In 1997, as the U. S. Air Force celebrates its 50th year


