### David O. Schillerstrom

Dave Schillerstrom, who was stricken with polio as a young officer at Torrejon Air Base, Spain, but overcame the disease to serve 30 years in Public Affairs, ending his career as SAF/PA Deputy Director, died March 13, after a 3-month battle with cancer. He was 84.

Interment at Arlington National Cemetery from the Old Post Chapel at Fort Myer with Full Military Honors will be at 11 a.m., Friday, August 22. A reception at the Fort Myer Officers' Club will follow. Those planing to attend the reception should RSVP by Sunday, August 17, to: carolgstrom@gmail.com or 703 524-8963.

David was born in Gibson City, Illinois. He graduated from Hinsdale High School, Hinsdale, Illinois, and from the University of Illinois in 1954 with a BA in English literature. He earned his MA in public administration from The George Washington University in 1966.

His early assignments included Turner AFB, Georgia; the 17th Bombardment Wing, Wright-Patterson AFB, Ohio; and Strategic

Air Command Headquarters, Offutt AFB, Nebraska. After completing Air Command and Staff College in 1966, he was a special projects officer in the Directorate for Plans and Programs, Office of the Assistant Secretary of Defense, Public Affairs.

He served at 7th Air Force Headquarters in Vietnam, returning in 1970 to become executive officer to the Air Force Director of Information.

Dave was appointed SAC Director of Information in 1977, serving there until he became SAF/PA Deputy Director in 1980. He retired from the Air Force as a colonel in 1984. That was not the

end of Dave's Public Affairs career, he became Vice President of Communications for the Aerospace Industries Association; a

post he held for ten years.

He is survived by his wife of more than 62 years, Carol Schillerstrom; son, David A. Schillerstrom; daughters Linda C. Schillerstrom and Karen Brownsword. Dave Schillerstrom was a legend in Air Force public affairs - a respected leader, expert communicator, outstanding mentor, and valued friend.

He was one of the real trailblazers in our business and demonstrated that one didn't have to wear wings to achieve the rank of colonel and provide wise counsel to senior Air Force leaders.

Dave and his effervescent wife, Carol, set the example for many of us junior officers and our spouses - they knew how to entertain, have fun, and make lasting friendships. They were ardent golfers and a real joy to be with on the course. One of my favorite memories was when Dave played golf with me and Florida State coach Bobby Bowden at a charity tournament outside DC. Hearing these guys trade stories and jokes on the course is something I'll never forget.

As Dave was nearing the end, I'm glad so many of his friends stopped by, called, or wrote to let him know how much both he and Carol had touched our lives. Though Dave was a very humble man, I know this outpouring of love provided him with some comfort in his final days. Let us not grieve but celebrate the life of this great man, patriot, and friend - here's to you, Dave!

### 21st Annual Membership Meeting Saturday, May 10, 2014 La Quinta San Antonio Convention Center San Antonio, Texas

**20th Annual Membership Meeting Minutes** – President Phil Ratliff presented the minutes of the 19th Annual Membership Meeting for approval. Don Black moved for approval, Dave Smith seconded and they were approved unanimously.

**Association Finances** – Treasurer Jim Hart presented the financial status of the Association.

Overall, the Association is in good financial condition. The AFPAAA fiscal year ends on Sept. 30. At that time, the Association had \$17,150 in the checking account and the Endowment Fund was \$325,449. The total net worth was \$342,599.

The initial goal for the Endowment Fund was \$300,000 with the expectation that it would generate \$15,000 per year to sustain the programs of the Association over and above the membership dues. Through contributions and growth, the value of the fund today is \$348,296. He also praised the work of the Investment Committee members Hank Hufnagel and Jim McGuire.

Treasurer Hart reported that the investment committee has overseen and increased the value of the endowment fund. In addition, the checking account had just under \$49,000, including registration fees and corporate donations for the annual meeting.

Treasurer Hart made a motion to approve the report as presented; it was seconded by David Smith and approved unanimously.

President Ratliff thanked Treasurer Hart and said that the Association wouldn't be where it is financially today without Jim as the treasurer and without our investment committee.

### **SAF/PA Liaison Report**

Liaison Art Forster reported that the Association will assist SAF/PA with an initiative to design the SAF/PA conference room as a tribute in memory of those Public Affairs professionals who lost

their lives in the line of duty. The Board approved up to \$3,000 to help pay for the cost of the memorial. He noted that Col Cook, SAF/PAdirector, appreciated our effort. He thanked the board, the membership, and SAF/PA for supporting this effort. Jerry Dalton asked a question about who will be honored in the conference room. The conference room will include a plaque that recognizes the Association for its donation.

The goals of the SAF/PA Liaison include communicating who we are and what we do for the career field. The Association is looking for ideas to raise visibility among the active PA forces and to encourage them to join the Association as associate members. Association members can expect to see more of an effort to increase awareness among the active PA forces in the future.

### **Committee Reports**

Web Site/Oral History – Committee Chairman John Gura noted that recent news about databases being hacked didn't affect the Association's online information. AFPAAA's database isn't in danger and is well protected from hackers. All Association members are reminded to update their information because many members forget to keep their information current. It's especially important to keep your information current because the Association, with approval from the chairman or president, sends out e-mail blasts about important information to members' e-mail addresses.

Some members have difficulty accessing the web site from certain IT systems. The issue isn't with the AFPAAA web site; it's a problem when a firewall on a government or corporate site blocks access to the Association web site.

There was nothing significant to report for the oral history program. Interested members should contact John and he will show them how to correctly prepare a report. Members should contact John via e-mail if they are having trouble accessing the Association's web site.

John offered kudos to Sam Giammo for leading the Association's social media effort. The Association maintains two Facebook accounts: the Association's members page has 245 followers and the Association's public page has 876 followers. Information posted on the Association's Facebook pages is also posted on the AF Band, AF Broadcasters, AFN Europe, AF Public Affairs, and DINFOS Trained Killers Facebook pages.

Communications — President Ratliff read the following communications update from Committee Chairman John Terino: "We continue to get excellent service and color reproduction at a good price from All American Printing in Alexandria, Virginia. The newsletter is you, the memberships' publication and we welcome your items and pictures for publication — awards, articles and books published, promotions, etc. — which should be submitted by the first of March, June, September, and December for publication in the April, July, October, and January issues."

Membership—President Ratliff said he will address the membership report during his President's update later in the meeting.

### **Board of Directors**

Election Results – Chairman Cox announced the results of the Board of Directors election. Elected for two-year terms were:

Annual Meeting Chairman – Perry Nouis will replace Linda Arnold as the annual meeting chairman. Linda has handled the key tasks of the Annual Membership Meeting for more than a decade.

2015 Annual Membership Meeting – The 22nd annual meeting will be held May 14-16, 2015 in Washington DC at the Hilton McLean Tysons Corner, 7920 Jones Branch Dr., Mclean VA, 22102. The local host will be Frank McNally. Frank briefed that on Friday the Association will visit the Pentagon's Conference Center, the 9/11 Memorial at the Pentagon and the Air Force Memorial where the group photo will be taken. Lunch on Friday will be at the Fort Myers officers club. On Saturday, we will visit the Air and Space Museum's Udvar-Hazy Center in the morning and have the annual membership meeting in the afternoon. Frank showed a video of the center. Art Forster suggested we consider attending the Friday night parade and ceremonies at the Marine Barracks in Washington, D.C.

### **New Business**

La Quinta Returns Points – Chairman Cox briefed that the La Quinta Returns Points program allows people to donate their La Quinta Returns Points to Fisher House Foundation Hotels for Heroes program, a service that provides free hotel stays to military family members requiring accommodations while loved ones are being treated at a medical facility far from home. As a La Quinta Returns member, you can help make an important difference for those who serve by donating Returns® Points to Hotels for Heroes. Brochures about the program were made available to the membership and more information was also available at the hotel's front desk.

Membership Campaign – Art Forster reported that the board discussed at length what the Association would like to look like in five or 10 years. The core membership continues to decline so the board emphasized that everyone needs to help with recruiting new members with an emphasis on our friends and colleagues who aren't current members. We also need to contact those who used to be members and who let their membership lapse. The board is planning to have an "every member recruit a member" campaign this year. The campaign details will be announced soon. It's expected that the campaign will include incentives to help current members recruit new members. Even without incentives, it's everyone's duty to think about the Association's legacy and to assure that we have members to carry on that legacy.

Donation to Lackland Organizations – Laura Feldman asked that since the Association donated \$500 to the memorial at Scott AFB during the 2012 annual meeting should we consider donating \$500 to the one of the Lackland places that we visited on Friday's tour. Treasurer Hart that this is a great idea but,

unfortunately, out charter only allows for donations to groups that fall under our Charter and IRS rules on donations. He reminded members that the same thing is true for silent auction proceeds. That money is not part of the Association funds.

DINFOS Renovation – Clem Gaines mentioned that DINFOS is in the midst of a significant renovation. When the renovation is complete the school will be a more modern and capable facility.

Request for Air Force Messages – Doug Kennett said he wished he knew what the current Air Force messages were so he can share them with others. The SAF/PA liaison will work to obtain current messages and then have them sent to all Association members as an e-mail Blast.

Air Force Public Affairs Hall of Fame – Art Forster reported another idea discussed by the board was establishing an Air Force Public Affairs Hall of Fame similar to the Army Public Affairs Hall of Fame. The Army Hall of Fame includes a web site that displays pioneers and all-stars honored by the Army Hall of Fame. The board will discuss the idea more and if decided to pursue this the membership will be provided more information. State of the Association – Chairman Cox noted that AFPAAA is in a great position for continued success in the future. He presented Phil with a vintage handbook of Roberts Rules of Order "to keep the crowd in line."

President Ratliff reported the state of AFPAAA was good and in superior financial health. The biggest challenge is membership.

Although we gained new members from the one-year free membership, a large number of those new members did not renew their membership. The Association needs to do something to encourage new memberships. Members can expect a renewed effort on obtaining new members after the Aug. 14, 2014 board meeting.

By-Laws Change – President Ratliff said that during the May 8, 2014 board meeting the board made the following amendment to the By-Laws, Article IV, Section 8, Action Without a Meeting of the Board of Directors:

That Section Read "Action required to be taken at a board of directors meeting may be taken without a meeting if the action is considered by all members of the board. The action shall be taken by the verbal or written consent of a majority of directors and documented in the corporate records as a memorandum."

It Now Reads "Action required to be taken at a board of directors meeting may be taken without a meeting, at the direction of the Chairman, if all members of the board consider the action, and each member is given an opportunity to amend or comment on the proposed action. The action shall be taken by the verbal or written consent of a majority of directors and documented in the corporate records as a memorandum at the next board meeting."

President Ratliff informed the membership to expect a survey in the fall newsletter about annual meeting frequency – whether the annual meetings should continue to be held annually or if they should be held every two years.

In conclusion, Phil said the Association is in good shape.

Adjournment – With no other business, Ken Rogge moved for adjournment, it was seconded by Larry McCracken, and the meeting adjourned at 2:35 p.m..

### Kodlick, McCollough Get President's Awards

AFPAAA Life Members Les Kodlick and Bob McCollough were announced as AFPAAA President's Award recipients at the 21st Annual Membership Meeting in San Antonio.

President Phil Ratliff presented the award, which is given to individuals who have had a significant impact on Air Force Public Affairs, to McCollough. Kodlick was unable to attend. Both recipients were selected for their distinguished, although different careers in Public Affairs.

Les, who retired from the Air Force in February, had 30-years of active duty, mostly in Air Force Public Affairs. During his final assignment as SAF/PA director, he guided the more than 5,500 active duty, Guard and Reserve Airmen and civilian personnel career



field during a period of exceptional stress involving rapidly evolving communications technology, multiple combat deployments, as well as other assignments world-wide, while dealing with shrinking budgets and personnel resources.

Bob had multiple accomplishment

in both the civilian and military worlds. He retired from the Air Force Reserve as a colonel where his last assignment was as the mobilization augmentee to the AFNews commander.

He is currently director of communications for Morgan's Wonderland in San Antonio, the world's first and only theme park designed with special-needs individuals of all ages in mind. Previously he retired as head of corporate communications for

CPS Energy of San Antonio, one of the nation's largest publicly owned natural gas and electric companies and from Sea World San Antonio. An accredited member of the Public Relations Society of America (PRSA), his programs have been recognized in three Silver Anvil competitions.
