# Jim Hart Doubly Honored: 'Best Of The Best' Renamed For Him; Presented McRaney Award

Jim Hart, the 'Gentleman Farmer' who lives in Bascom, Florida, with his wife Patty, and enjoys nothing more than "driving my tractor and cutting hay", was in the spotlight twice at the April 29th 24th Annual Membership Meeting banquet.

First, he received AFPAAA's Brigadier General Mike McRaney Distinguished Service Award for his more that 24 years supporting AFPAAA.

The many things he did included designing, establishing, and guiding the endowment fund, providing the printing for the newsletter when we began, serving as the second Brigadier General Mike McRaney chairman of the AFPAAA Board of Distinguished Service Award. Jim Directors and then as treasurer didn't know yet the Best of the Best Award (right) was renamed for him. until last year. It was an award he earned and deserved many time over but refused to accept until he left the board.

It was the second honor that surprised Jim and highlighted the evening - the renaming of the top award in Air Force Public Affairs as The Brigadier General James W. Hart, Jr. Best of the Best Award.

Previously known as the Best of the Best, the AFPAAA Board felt that Jim's distinguished career in Air Force Public Affairs as well as his parallel civilian public relations career deserved the renaming of the award; the Air Force agreed.

There was no hint when he began as an Aviation Cadet in 1958 that Jim's almost 37 year Air Force active duty and reserve

career, would culminate with him a general who served as the mobilization assistant to six Air Force Directors of Public Affairs, and included being called to active duty to support senior Air Force leadership during Operations Desert Shield and Desert Storm.

He entered Public Affairs in the AF Reserve in 1961 as an Information Technician with the 32nd NORAD/CONAD Region, Gunter AFB, Alabama. He received a direct commission in the Air Force Reserve through the Outstand-

ing Airman Commissioning Program and was Chief of Public Affairs, 187th Tactical Fighter Group, Alabama Air National Guard and then Director of Public Affairs for the Alabama Air National Guard.

There followed a series of assignments and promotions that were Jim's road to SAF/PA. In succession he was the mobilization

augmentee to the Director of Public Affairs, Lowry Technical Training Center, Lowry AFB, Colorado, where he was named outstanding reservist for Air Training Command; Deputy Chief of Community Relations, Headquarters U.S. Air Force, and SAF/PA Assistant Director of Public Affairs.

> Jim's civilian career took an equally upward slope leading to vice president of public affairs for Duke Energy Corporation. Just as with the Air Force, his civilian career started off inauspiciously.

In the mid-1950s he got a start in broadcasting on the Chipola College station in Marianna, Florida; became anchor and news director for WSFA-TV, NBC's Montgomery, Alabama, affiliate, and then was executive director of the American Petroleum Institute in Alabama for 13 years. Jim was senior director of public affairs for Gulf Oil Corporation until 1985 when it was acquired by Chevron. He

then joined Hill & Knowlton, Inc. as senior vice president and general manager of its Denver office.

In 1988 he became vice president, corporate communications, PanEnergy Corporation, Houston, Texas, with responsibility for internal and external communications, media relations, public relations, advertising, employee and financial publications, design graphics and printing, community relations, audiovisual services and corporate contributions. Under his guidance PanEnergy won four PRSA Silver Anvils and two IABC Gold Quills. When Duke Power merged with PanEnergy to form Duke Energy he was the new

company's vice president of public affairs until retiring in 1998.

In addition to his dual careers Jim had a lot of other things happening between his graduation from Chipola in 1956 and now. He earned a Juris Doctor degree in 1973 from the University of Alabama Law School and an Executive MBA from MIT's Sloan School of Management in 1982. Always active in professional organizations and community affairs, he received numerous awards recognizing his public relations expertise and community service, and has

scholarships and awards named to honor him.

In addition, Jim is a Certified Flight Instructor with single engine, multiengine and instrument ratings. He has flown more than 7,000 hours in 25 military and civilian aircraft. In 2009 he received the Federal Aviation Administration Wright Brothers "Master Pilot Award".

From high school to Air Force's enlisted ranks in intelligence to selection for the premier award in Public Affairs is pretty amazing. Bryan Bouchard, the recipient of SAF/PA's 2016 Brigadier General James W. Hart, Jr. Best of the Best Award did just that.

Shortly after his birth in California, Bryan's family moved to Medford, Oregon, where his Air Force career began. He graduated from high school in 1995 and enlisted as a Hebrew Cryptologic Linguist, serving in that

capacity until 1999 when he retrained into Public Affairs. The rest of his career can only be described as one of excellence.

After DINFOS he was the base newspaper editor and eventually NCOIC at Seymour-Johnson AFB, North Carolina. He moved to Fort Dix, New Jersey in 2003 to become the Public Affairs Instructor at the 421st Combat Training Squadron for successively the Phoenix Readiness, Eagle Flag, and Combat Airman Skills Training programs. In addition to the Public Affairs curriculum he taught other subjects including troop-leading procedures, convoy operations, and small team tactics. As an EM he received two Air Force awards: 2002 Best Metro Newspaper and 2005 PA NCO of the year.

Bryan completed his Bachelor of Arts degree in liberal studies at Thomas Edison State University, New Jersey in 2006. He separated as a technical sergeant and entered Officer Training School, earning a commission in March 2007. After commissioning, his Public Affairs assignments included the 56th Fighter Wing, Luke AFB, Arizona; 18th Wing, Kadena Air Base, Okinawa, Japan; SAF/PA's



#### **Roy P. Whitton**

Roy Whitton, one of the first Lifetime Founders of AFPAAA and one of our strongest supporters, died at Good Shepherd Hospice, Sebring, Florida, April 13. He was 94.

Roy's military service began when he enlisted in the Army Air Corps on January 6, 1941. He was initially stationed at Albrook Field, Panama Canal Zone but then was transferred to Baltra Island in the Galapagos archipelago as chief of the heavy bomber instrument shop.

He was discharged as a staff sergeant when World War II ended and entered Ball State University, Muncie, Indiana, where he earned bachelors and masters degrees in Education.

Roy joined the Air Force Reserve as staff sergeant in 1948 and received a direct commission as a second lieutenant. He in Japan. His efforts in Japan were recognized as the 2011 Public Affairs Best Integrated Communications Program. In 2016 he was the Public Affairs Company Grade Officer of the Year. In his career he has received more than 30 Air Force and MAJCOM Public Affairs awards.

Bryan was promoted to major January 1 and retired April 1. He lives in Phoenix with his wife, Jenna, an attorney, and their children Hayley, 12, Felix, 4, and August 3. Currently he is looking for opportunities to use the communication skills he developed in the Air Force for employment in the civilian world with the possibility of entering law school next year.

The recipient of the Brigadier General James W. Hart, Jr. Best of the Best Award, sponsored by Lockheed Martin, is chosen by SAF/PA. It recognizes the top officer, civilian, or enlisted person in Air Force Public Affairs for professional excellence and significant contributions to the effectiveness of the Air Force mission. In addition to the trophy, Bryan receives a check for \$1,000 and a life membership in AFPAAA.

was on active duty during the Korean War as the Information Officer at Williams AFB, Arizona.

He returned to civilian life in 1955 but stayed active in the Air Force Reserve as a mobilization augmentee with assignments that included Military Airlift Command and the Secretary of the Air Force Office of Information.

Roy retired in 1982 as a colonel with more than 41 years of active duty and reserve service.

He stayed close to the military through membership in the American Legion and the Air Force Association, including being a District Commander and state vicecommander of the Legion in Indiana, and organizing and serving as first president of the Indiana American Legion Press Association.

A charter member of the Air Force Association, he served as president of the Indiana and Florida AFA and as a national vice-president. He was also instrumental in

establishing several Air Force Junior ROTC units in Florida. Roy is survived by his wife, Glenda "Kay" Browning Whitton; his son, Matthew; stepdaughters Candy McCarty, Cally Stockton, and Christy Rosson; 11 grandchildren, and 9 great-grandchildren.

**23rd Annual Membership Meeting Minutes** – President Judy Bivens presented for approval the minutes of the 23rd Annual Membership Meeting, held May 14, 2016, at the DoubleTree Hotel in Colorado Springs, Colorado. Jim Ragan moved for approval, Dave Smith seconded and they were approved unanimously.

**Financial Report** – Treasurer Phil Ratliff presented the financial status of the association. He reported that the net worth of the organization is now \$407,000. The endowment fund earned a 10% return on investment last year, and has grown by 4% so far this year. Treasurer Ratliff made a motion to approve the report as presented; it was seconded by Mike Terrill and approved unanimously.

**SAF/PA Liaison Report** – Liaison Art Forster reported that Brigadier General Ed Thomas has indicated he will appoint the new SAF/PA civilian deputy, Jerry Renne, as his liaison to AFPAAA. The remodeling of the SAF/PA conference room is nearing completion and will include a Memorial Wall funded in part by a contribution from AFPAAA. A plaque on the wall will recognize our contribution.

#### **Committee Reports**

**2018 Annual Membership Meeting** – Perry Nouis reported that next year's meeting will be held May 31 through June 2, 2018, at the Sheraton San Diego Hotel and Marina in San Diego, California. We're looking for an East Coast location for the 2019 annual meeting. Possible sites being considered by the Board include Charleston, South Carolina, and Langley AFB, Virginia.

**Membership** – Committee Chairman Neil Buttimer reported that we have about 480 people who compose the association's core membership. Normally we have a renewal rate of about 75%, however this year it's down to about 50%. Flip through the membership directory and look for the names of your friends who aren't listed there but should be -- and then invite them to join.

**Communications** – Committee Chairman John Terino said he continues to be pleased with the printer we're using. John reminded everyone to send in news items for publication. Obituaries and tributes are published in the newsletter for all public affairs professionals, both members and non-members. John asked everyone to please notify him whenever a PA passes, and then send in memories of their service to be printed as tributes.

Web Site/Oral History – Committee Chairman John Gura reminded everyone to visit the web site regularly for news about

the association and the career field, and to use the web site to keep their e-mail address and contact information updated.

**AFPAAA 2020 Initiative** – President Bivens introduced the AFPAAA 2020 committee chairs for updates on their efforts.

Finance: Treasurer Phil Ratliff reported the finance committee has projected that within the next two years the association could become a half-million dollar organization. They suggest that the association consider expending some of our endowment account so that the balance doesn't grow too large.

Operations: Secretary Tom Dolney reported the operations committee has made progress on creating a continuity book that summarizes the duties of each position in the association. The next step will be updating the wording in our bylaws to correctly reflect the current structure of the organization.

Membership: Connie Custer has reached out to our alumni association counterparts in both Army and Navy Public Affairs. She has collected information from the Army and hopes to soon get inputs from the Navy. She is using social media to survey younger PA professionals to gather ideas to improve recruiting.

Meetings: John Gura reported his committee has been looking at three primary issues – increasing participation in annual meetings, reducing costs for both the association and its members, and picking meeting locations that are easy to get to.

#### **Old Business**

Hall of Fame – Art Forster gave an update on the effort to establish an Air Force Public Affairs Hall of Fame. We had been working with SAF/PA to establish a hall of fame but the process stalled while the civilian deputy position sat vacant. Brigadier General Ed Thomas has indicated his support for establishing a Hall of Fame and we look forward to restarting the effort with the new deputy.
